

# RATES AND CHARGES FOR PERMISSION TO USE COUNCIL OWNED AND/OR MANAGED LAND FOR FITNESS AND TRAINING CLASSES

## Important Information:

These rates and charges do **not** relate to the London Borough of Ealing's (LBE) sports pitches. All enquiries relating to booking sports pitches should be emailed to ealingsports@amey.co.uk

Rates and Charges will be reviewed and confirmed annually

This document has been created to give the most accurate indication of the costs involved with holding Fitness and/or Training Classes in the London Borough of Ealing's (LBE) parks and open spaces. It is possible that each organisation or business delivering these activities will do so differently. Therefore the following form might not capture certain elements of your Fitness and/or Training classes that, ultimately, will affect the charge the Council makes in relation to your application. Please speak to a member of the **Community and Street Events Team** for an accurate quote.

## Charges in relation to a Single Training Session:

If you want to hold a single training session for **50 people or less** then you must pay a fee of **£50.00**

There must be at least 28 days between single training sessions by any particular applicant.

If you want to offer a single training session to **more than 50 people** or hold two days back to back then you can do so by completing a park hire application form and submitting it to a member of the **Community and Street Events Team**.

Single Training Sessions must be in line with the **Licensed Fitness Operator Terms and Conditions**.

## Charges in relation to Personal Trainers:

A Personal Trainer permit will allow the bearer to charge for training instruction in any of the Borough's parks and open spaces.

These training sessions must have no more than **two people** being trained at a time.

Personal Trainers can operate as often as they wish in any of the Borough's parks and open spaces so long as it is in line with the **Licensed Fitness Operator Terms and Conditions**.

Annual Rate:	£ 300.00
Summer Rate:	£ 225.00
Winter Rate:	£ 150.00

## Charges in relation to Group Classes:

A Group Class permit will allow the bearer to charge for training instruction in a **single park or open space**.

These training sessions can be for as many people as requested, at the time of making an application.

Group Classes can only operate **twice per week** in a single park which must be specified when you make your application. Subject to availability.

A Community and Street Events Coordinator can approve up to one more training session per week. This will incur a **20%** surcharge.
