Details of claim (continued)

- 1. The Claimant, the London Borough of Ealing seeks an interim and final injunction pursuant to section 222 of the Local Government Act 1972, section 187B of the Town and Country Planning Act 1990 and section 130 Highways Act 1980.
- 2. The Claimant owns and / or is responsible for the management of the Parks, Sports Fields, Leisure Areas, Agricultural Land, Woodland Areas and Open Spaces ("the Green Spaces") in the Borough. In addition the Claimant owns and is responsible for the Housing Estates, Car Parks and Leisure Facilities.
- 3. In total there are 182 Green Spaces needing protection. There are 124 Housing Estates. In addition there are 33 Leisure Facilities and Car Parks. The Green Spaces are identified by a number on Map 1 and listed on Schedule 1. The Housing Estates are identified by a number on Map 2 and listed on the Schedule at Map 2, whilst the Car Parks and Leisure Facilities are identified on Map 3 and listed on Schedule 3.
- 4. As explained in the witness statement of Paul Murphy produced on behalf of the Claimant, there have been numerous incidents of unauthorised encampments and the depositing of waste, including the fly-tipping of commercial waste in the Borough resulting in considerable inconvenience and expense. The Borough fears further unauthorised encampments on the locations within Ealing by Persons Unknown Occupying Land and Persons Unknown Depositing Waste or Fly-tipping on Land.
- 5. These unauthorised encampments include large groups of Travellers with up to 30-50 people and 20-30 vehicles, mobile homes and caravans. There are also a number of dogs;
- 6. The unauthorised encampments have been established on the locations, all of which belong to the Claimant. In addition other land in the Borough owned by private landowners and businesses have been affected.
- 7. The witness statement provided by the Claimant demonstrates the disruptive and harmful impact of these unauthorised encampments as well as the health and safety concerns they raise. The harm this could cause to the residents of Ealing, among other members of the public is significant. The health risks to the residents include:
 - (1) human and animal excrement left in the Green Spaces from those establishing the encampments;
 - (2) domestic waste strewn over the land;
 - (3) fire hazards caused by the use of propane gas cylinders in public spaces;
 - (4) fly-tipping domestic and industrial scale waste, including building materials, glass, asbestos, rubble and soil;
 - (5) driving of vehicles over and across Parks, Recreational Areas, Woodland Areas.
- The unauthorised encampments cause considerable disruption to the residents and visitors of Ealing.
- 9. The fly-tipping causes considerable distress and anxiety and results in recreational facilities being un-usable.
- Further considerable expense is incurred in the cleaning up operations including the removal of untreated human excrement, domestic litter, general waste, gas cylinders and building waste, including hard core and soil;
- 11. The unauthorised encampments also cause considerable expense to be incurred in restoring the sites to a fit, hygienic and safe level for usage by the public. Further costs are incurred in attempting to secure the sites owned by the Claimant.
- 12. Since May 2018, unknown persons have formed at least 54 encampments on the Claimant's land within the Borough.
- 13. To date, the Claimant and the police have been dealing with repeated encampments through the procedures available under Sections 61, 77 and 78 of the Criminal Justice and Public Order Act 1994. These are reactionary steps addressing the problem after the encampments have been established and after the fly-tipping damage has taken place.
- 14. As demonstrated by the evidence filed in support of this Claim, these procedures have not acted as a significant enough deterrent and it is not uncommon that immediately following the clearance of an unauthorised encampment, another one is set-up. On some occasions the unlawful occupiers have returned to a Green Space or Car Park that has been the subject of earlier clearance and removal.

- 15. Accordingly, for the reasons set out in the witness statement in support of this Claim, it is necessary and expedient for the promotion and / or protection of the interest of the residents of Ealing and to prevent nuisance and trespass and further breaches of planning control to seek an injunction in the terms of the draft Order attached to this Claim.
- 16. An injunction will prevent the repeated establishment of unauthorised encampments and the disruption and loss of resources caused by this type of unlawful action.
- 17. It is necessary to bring these proceedings against (1) Persons Unknown Occupying Land and (2) Persons Unknown Depositing Waste or Fly-tipping on Land as the identity of the unlawful occupiers is uncertain and in any event such names as are given are often found to be false names.
- 18. The proposed Order is intended to prevent any future unauthorised encampments on the Green Spaces, Leisure Facilities and Car Parks being established by the (1) Persons Unknown Occupying Land and (2) Persons Unknown Depositing Waste or Fly-tipping on Land.
- 19. The draft Order against (1) Persons Unknown Occupying Land and (2) Persons Unknown Depositing Waste or Flytipping on Land has confined the scope of the order to specifically identifiable sites within Ealing as identified on the attached Maps.

Where a Person Unknown Occupying Land and / or Depositing Waste or Fly-Tipping on Land is arrested under the power given by Section 27 of the Police and Justice Act 2006:-

- A Person Unknown Occupying and / or Depositing Waste or Fly-Tipping on Land shall be brought before the judge within a period of 24 hours beginning at the time of their arrest;
- A Constable shall inform the person on whose application the injunction was granted, forthwith where a Defendant is arrested under the power given by Section 27 of the Police and Justice Act 2006

Nothing in Section 27 of the Police and Justice Act 2006, shall authorise the detention of a Person Unknown Occupying and / or Depositing Waste or Fly-Tipping on Land after the expiry of the period of 24 hours beginning at the time of arrest

AND UPON ANY PERSON FROM THE GYPSY AND TRAVELLER COMMUNITY WHO WISHES TO ATTEND THE HEARING OF THE PART 8 CLAIM IF THEY WISH TO DO SO

AND UPON THE CLAIMANT UNDERTAKING TO THE COURT TO FORTHWITH NOTIFY THE LONDON GYPSY AND TRAVELLERS GROUP OF THE TERMS OF THIS ORDER

IT IS ORDERED THAT, UNTIL THE HEARING OF THE PART 8 CLAIM OR FURTHER ORDER AS FOLLOWS:

The Defendant as Persons Unknown Occupying Land and / or Depositing Waste or Fly-tipping on Land are forbidden from:

- (1) Setting-up an encampment on any Land identified on the sites numbered 1 to 182 on Map 1, 1 to 124 on Map 2 and P1-P17, L1 to L8 and C9 to C16 on Map 3 listed on the attached Schedules marked "1", "2" and "3", without written permission from the Local Planning Authority, or planning permission granted by a planning inspector;
- (2) Occupying any part of the Land identified on the sites numbered 1 to 182 on Map 1, 1 to 124 on Map 2 and P1-P17, L1 to L8 and C9 to C16 on Map 3 listed on the attached Schedules marked "1", "2" and "3" for residential purposes (temporary or otherwise) including with caravans, mobile homes, vehicles, and residential paraphernalia;
- (3) Bringing on to the Land identified on the sites numbered 1 to 182 on Map 1, 1 to 124 on Map 2 and P1-P17, L1 to L8 and C9 to C16 on Map 3 listed on the attached Schedules marked "1", "2" and "3" any vehicle whether for the purposes of disposal of waste and materials or otherwise, other than when driving through the Borough of Ealing or in compliance with the Parking Orders regulating the use of car parks or with express permission from the owners of the Land.
- (4) Depositing any personal, domestic or commercial waste and / or fly-tipping on any of the sites numbered 1 to 182 on Map 1, 1 to 124 on Map 2 and P1-P17, L1 to L8 and C9 to C16 on Map 3 listed on the attached Schedules marked "1", "2" and "3".

- (5) "The Land" means all the land within the London Borough of Ealing identified on the attached Maps and on the sites listed on the attached Schedules.
- (6) "Occupying" means remaining in for the purposes of treating as a place of residence or as a dwelling;
- (7) "Encampment" means a place of temporary shelter for the purposes of accommodation
- (8) Service of this Order shall be deemed served pursuant to CPR 6.27 by affixing a copy of this Order as opposed to an original contained in a transparent waterproof envelope or laminated

- copy in a prominent position at each of the entrances to the Land identified on the attached Maps and listed on the Schedules;
- (9) Any person who is presently a Person Unknown (or anyone notified of this Order) who wishes to identify him or herself and join as a named Defendant to the proceedings may apply to the Court on 72 hours written notice to the Court and the Claimant to vary or discharge this Order (or, so much as it affects that person).
- (9) There shall be a power of arrest attached to paragraphs 1 to 4 of this Order.

Directions for Service of this Order & Part 8 Claim

1. Service of this Order and Part 8 Claim shall be effected at each of the sites referred to in the Schedules and shown on the attached Maps by affixing copies of this Order (as opposed to an original sealed Order) contained in transparent waterproof envelopes or laminated copies in a prominent position at each of the entrances to the Land together with a Notice that a copy of the Part 8 Claim Form and Notice of Hearing and supporting evidence can be obtained from London Borough of Ealing, Perceval House, 14-16 Uxbridge Road, Ealing, W5 2HL during normal Council opening hours and on the Council's website.

Application to Vary or Discharge This Order

2. Any person who is presently a Person(s) Unknown (or any person notified of this Order) and who wishes to identify themselves and be joined as a named Defendant to this Claim may apply to the Court to be so joined on 72 hours' notice to the Court and to the Claimant, and/or to vary or discharge this Order (or part of it) including upon the basis of their personal circumstances (including grounds of hardship or health).

Directions for Hearing of Part 8 Claim

- 3. The Claimant shall file (and serve upon any named Defendants joined to this claim) further evidence in support of this Claim by not later than 3 days prior to the hearing of the Claim. Such evidence shall include:
 - (a) evidence of title and evidence of service in accordance with the terms of this Order;
 - (b) evidence of any unlawful incursions and fly-tipping following the making of the Order and the risks of such future potential incursions or fly-tipping;

- (c) evidence as to any enforcement action taken in pursuance of this Order, including informal enforcement measures;
- (d) evidence as to how the welfare considerations of Travellers who may be affected by the terms of this Order and any final order sought, including the interests of Travellers wishing to come into the Borough have been or will be dealt with.

7. A Person Unknown Occupying and / or Depositing Waste or Fly-tipping on Land (or anyone notified of this Order) who is an individual who is ordered not to do something must not do it

by him or herself or in any other way. He/she must not do it through others acting on his/her behalf or on his/her instructions or with his/her encouragement.

8. A Defendant which is a corporation and which is ordered not to do something must not do it itself or by its directors, officers, employees or agents or in any other way.

PARTIES OTHER THAN THE CLAIMANT AND DEFENDANTS Effect of this Order

9. It is Contempt of Court for any person notified of this Order knowingly to assist in or permit a breach of this Order. Any person doing so may be sent to prison, fined or have his/her assets seized.

UNDERTAKINGS

- 10. The Claimant will serve a copy of this Order in a transparent waterproof envelope or laminated copy in a prominent position at all the entrances to the Land on the sites numbered 1 to 182 on Map 1, 1 to 124 on Map 2 and P1-P17, L1 to L8 and C9 to C16 on Map 3 listed on the attached Schedules marked "1", "2" and "3" with a notice that a copy of the supporting evidence can be obtained from Perceval House, 14-16 Uxbridge Road, Ealing, W5 2HL during normal Council opening hours or on the Council's website.
- 11. The Claimant will place a copy of this Order together with the evidence served in support and the Part 8 Claim Form on the Claimant's website.
- 12. The Claimant will notify the London Gypsy and Travellers Group of the terms of this Order and of the Hearing Date.






