ORDER

UPON THE COURT reading an email from the London Gypsies & Travellers dated 6th June 2019 to the Claimant's solicitors proposing an adjournment of the final hearing in this claim

AND UPON THE COURT noting that the London Gypsies & Travellers are Intervenor in separate proceedings brought by the London Borough of Bromley heard on 15th and 17th May 2019;

AND UPON THE COURT noting that following the judgment of Ms. Leigh-Ann Mulcahy QC (sitting as a Deputy Judge of the High Court) the London Borough of Bromley have lodged an Appellant's Notice against the decision of Ms. Mulcahy QC to which the Intervenor will continue to be involved;

AND UPON THE COURT reading a letter from London Gypsies and Travellers dated 3rd July 2019 confirming that they support these proceedings being adjourned until after determination of the above-mentioned appeal

AND UPON THE COURT noting that the Intervenor's have agreed that the Interim Injunction Order of Mr. Justice Lang sealed and dated 10th May 2019 shall remain in force until the final hearing of this claim, or further order;

IT IS ORDERED

1. The final hearing of this claim, listed for 19th July 2019, shall be adjourned until such time as the appeal referred to above is determined or is otherwise concluded, with a time estimate 2 hours.
2. No order as to costs
