

OVERVIEW



The management of traffic flow through the London Borough of Ealing is an important job, the borough is one of the most populated districts in the UK, home to over 342,000 people and has around 470 million miles of accumulated through vehicle journey's each year. Perhaps it's not surprising that cars, motorbikes and buses all play a big role in the lives of our residents with 33% of people living in the borough choosing to travel to work by motor vehicle.

The job of keeping traffic moving falls to the Council, with the management of parking playing a significant role in improving road safety, congestion, the environment and making life easier for all road users, whether in a vehicle or on foot.

In June 2019 Ealing Council published its Transport Strategy. This document sets out, in respect to transport, what we aim to deliver and why those aims are important. Providing a safer, cleaner and more accessible place is the key objective of the Highways, Parking and Transport services. We that these policies need to fit into a wider London and national objectives. Ealing's lead member, Cllr Bell who is Transport & Environment Committee chair for London Councils has said:

The ways in which these aims will be met by Parking Services are detailed in the Parking Plan (due for publication later in 2019). The latter document provides some information on which operational policies that will be used to achieve the strategic goals in the former. The Parking Annual Report provides information on the outcomes of these policies. It provides some insight into the work undertaken by Parking Services.

BLUE BADGE FRAUD AND MISUSE PREVENTION

COUNCIL CAR PARKS

Blue badge fraud is sometimes seen as a victimless crime. This is inaccurate. Even in instances where the blue badge being abused has not been stolen, the use of the space deprives those with genuine need of using Ealing's disabled bays.

These bays are typically located conveniently close to local amenities in order to reduce the distance of a journey from the car to a destination, or beside the homes of those with mobility difficulties.

We are always keen to take tough action against the selfish people who commit blue badge fraud, and now lodge the 5th highest number of prosecutions against misusers in the UK – this is quite an accomplishment given the geographic size and population of Ealing. In 2018/19 we inspected 1,600 badges, successfully prosecuting 70 individuals. We did not lose a single case. £50k in Council costs, court costs and victim surcharges has been recovered from the fraudsters over this time.



Parking Services manage 17 public off-street car parks in the borough. These serve a wide range of customers, including shoppers, visitors to local tourist attractions and those parking for longer periods.

In November 2018 Singapore Road Car Park in West Ealing was closed to make way for development of new housing in the Green Man Estate. The car park has been replaced with a brand new facility at William's Road.

As the level of parking demand increases around the borough we are reviewing the number of permits we sell in our car parks to ensure we can offer a sufficient number of spaces for short stay visitors, who are given higher priority than commuters when space is scarce.

We also work with the British Parking Association and the local police to ensure our car parks are safe for all our users. Nearly all our car parks have been certified as 'Park Mark' accredited – and have been inspected by the police who have confirmed they offer a good standard of safety for users.





In 2018/19 a procurement exercise was undertaken by the Council for a wide variety of Parking Services. Since 1 April 2019 the services have been provided by new suppliers, under new contracts. The table below shows the changes that have occurred in the providers of parking services in Ealing.

Following an examination of the parking marketplace, officers decided the best approach to procurement was to invite companies to submit bids through a process of negotiated tendering, as defined by OJEU (the Official Journal of the European Union). The tenders for these contracts were scored based on a 50:50 split between the price bidders could offer and the quality of the services provided.

The new contracts are expected to deliver financial savings of approximately £800k per annum (against an original budget of £4m per annum). What is particularly impressive, however, is the fact that many of the services provided will be improved or expanded whilst delivering these savings. Such improvements will include:

- Free text message reminders for those using the phone/online parking service
- A commitment to improving the condition of the multi-storey car park interiors
- Funding for an apprentice
- Ongoing financial commitment to parking related innovation
- Relocation of the enforcement operation to a private site, allowing re-use of the original site by the Council

Over the next 12 months we will consistently review the performance of the new contractors to confirm if they are delivering the quality of service we expect of them. We will report how they got on in next year's report.

ELECTRIC VEHICLE CHARGING



If you see the symbols below on a road sign, it means the spaces are for electric vehicles/electric bikes (respectively).





Ealing Council is establishing a network of charging points to meet the expected increase of electric vehicles on our roads.

We have already begun installing charging points where there is already some demand, ensuring that the new infrastructure can accept payment from all electric vehicle payment plans. To find an electric charging point in Ealing, anyone can visit the link below...

Not all charging points are the same. Following the completion of contract discussions, the Council has appointed a commercial provider (Bluepoint) to install fast charging models and has partnered with the PFI Lighting Contractor (SSE) to provide standard chargers in lamp columns. Electric vehicle chargers will now be included in parking zone design as a matter of course.

Rapid chargers will also be installed where the National Grid's electrical loading limitations permit. These are being planned and installed on a regional basis by TfL. It is likely that these will be based on locations at or near taxi ranks given TfL's commitment to making all taxis zero emission capable. Many of these rapid chargers will be available for public use.

In addition, it is expected that commercial providers will continue to install EV charging points on private land, such as petrol stations or car sales establishments.

STATISTICAL REPORTING

This is a natural consequence of the additional controlled parking zones (CPZs) that were introduced in 2018/19 and the increase in the number of CCTV cameras.

The following data doesn't show all the complaints received by Parking Services during the last two years – only those where the correspondent was dissatisfied with the response they received to an informal complaint or enquiry and wished to escalate the matter through the Council's formal complaint procedure.

The 'Complaints' column denotes that the origin is from individuals. 'Members Enquiries' are complaints or questions received from Councillors or MPs on behalf of constituents; 'Late' means the number of complaints/enquiries responded to past the designated timeframe (10 days).

FINANCIAL INFORMATION



The objective of Parking Services is to manage parking demands in a safe and appropriate way rather than generate income or revenue. However, any income generated through parking enforcement is ring-fenced by law and must be spent on transport and highways related initiatives.

In 2018/19, £21.898m was raised from on and offstreet parking income. The expenditure items directly associated with running a parking service totalled £6.954m. The remaining income is classed as 'surplus' and totals £13.48m. A contribution of £11.98m was made towards the council's cost of concessionary fares in 2018/19 including funding of the Freedom Pass.

The surplus contributes towards the part funding of the Freedom Pass, which provides free travel inside London to older and disabled residents.

The surplus generated by the service also funded several projects including the introduction of Controlled Parking Zone extensions, the removal of graffiti from street furniture and the parking enforcement operation into the investigation and prevention of blue badge misuse. Income was also used for court and tribunal services related to PCNs.
