Neighbourhood 27— Greenford Road

Background

This consultation is seeking your views on the proposed Highway improvements along Greenford Road from Oldfield Lane North to Green Park Way, Greenford. The proposal aims to improve the public realm for pedestrians and cyclists by installing a new segregated cycle track, improved crossing facilities and other general highway improvements in the area.

As part of Ealing Council's Neighbourhood programme, we have developed proposals to improve safety for cyclists, improve crossing facilities for pedestrians and cyclists and reduce vehicle speeds along Greenford Road.

We propose to narrow the carriageway, which will encourage drivers to reduce their speed, while retaining the capacity of the road. This will also allow us to install a new two segregated cycle track with zebra crossings for both pedestrians and cyclists. These proposals will encourage more walking and cycling along Greenford Road, in line with the Mayor's Transport Strategy and the Ealing Transport Strategy.

Existing Issues

- Lack of dedicated cycling facilities
- Lack of safe crossing facilities for pedestrians and cyclists
- Unnecessarily wide carriageway which encourages vehicle speeding

Proposals

- Proposed new two way segregated cycle track between Oldfield Lane North and Green Park Way
- Three new parallel zebra crossings which can be used by both pedestrians and cyclists
- Proposed junction upgrade to existing traffic signals at Berkley Avenue and Horsenden Lane North
- Closure of Oldfield Lane North junction with Greenford Road to simplify traffic movements in the area.

Benefits of the Proposals

- Greatly improved provision for cyclists
- Easier for pedestrians and cyclists to cross the street
- Improved safety and accessibility for all road users
- Improved public realm and reduced traffic speeds
