



I am pleased to introduce Ealing Council's Parking Annual Report for 2019/20.

This report provides information and updates on the services' priorities and challenges across the borough while highlighting some of our achievements throughout

19/20 and future developments and opportunities for the coming year.

Ealing's parking team provide a range of vital services to residents, businesses and visitors to our borough.

A key challenge has been our response to Covid-19.

A key highlight this year has been a rise in the provision of electric charging points across the borough which we hope will continue to spur the drive towards electric vehicles. The team also started decommissioning some pay & display machines within the borough which will aid the shift to variable charging for short stay, non-residential parking sessions.

The aim is to stimulate modal shift, lower transport's environmental footprint and improve road safety.

As well as outlining our plans, this report provides a range of key data and valuable information from complaints through to parking income, our prices and sales by product. There is also detailed information on the types of PCNs issued as well as about our public pay and display car parks.

The Council is committed to being open and transparent about its parking operation. We publish our parking and enforcement report each year to keep the local community and other interested parties abreast of any changes the we have made and any we are considering for the future.

Parking controls play an important part in the Council's transport strategy by regulating the amount of traffic within the London Borough of Ealing and encouraging the use of public transport. We believe that parking issues affect everyone who uses our streets, not only car users.

Demand for parking in the London Borough of Ealing far compensates the supply of kerb space available and we seek to maintain a balance between the different demands – from residents, businesses and visitors, whilst ensuring there is good access for pedestrians, cyclists, buses and other vehicles.

Our general policy is to provide the maximum number of car parking spaces while allowing the satisfactory and safe movement of traffic and the maintenance of a good quality residential environment. FUTURE PLANS

During fiscal year 2020/21 Ealing Council will introduce variable pricing for pay and display & phone parking customers, based on vehicular emissions. This is in response to the climate change emergency called by the Council in 2019. We are doing this to encourage the user of less polluting vehicles, and have already introduced emission-based pricing for our residential permits

We expect this change to have a positive impact on the emission levels of greenhouse gases, emissions that affect air quality such as nitrous oxides, and possibly the volume of traffic on our streets. It will work like this:

- 1. Visitors paying for parking will be asked to enter their vehicle registration into the PayByPhone mobile phone app (as most people do already
- 2. The app will identify the emissions produced by the vehicle by checking a database containing information from the DVLA and vehicle manufactures
- 3. Finally, discounts will be applied to their parking tariff depending on the green credentials of the vehicle being used

More information on emission-based charging will be released before the system is rolled out.

The discount will only be available through the mobile phone app and we are encouraging all our visitors to make use of this service. The usage of the machines continues to decline, year on year, and so the number of pay and display machines across the borough is being reduced this year, both to save money, address the problems of theft and vandalism, reduce street clutter, and minimise the carbon footprint of our parking operation. Unlike some Councils, Ealing will not be removing all of it's pay and display machines at this time, but the lesser used ones. Initially 57 out of 196 machines will be decommissioned, with further removals possible pending a review of the pros and cons of removal of the first machines

Various measures are used by the Parking Services team to determine if parking in Ealing is working well. There has been a decrease in the number of penalty charge notices (PCNs) issued this year.

During the 2019/20 year, we mobilised new parking enforcement contracts as well as Parking IT, Parking Payment and Enforcement Agents which involved

numerous changes for the process, contractors and operations (in the short term). We also had a change of main contractor for enforcement. Additionally, we were also subjected to a prolonged industrial dispute with our contractor's workforce that has only recently been resolved. These factors combined to produce significant under-performance within the enforcement team

COMPLAINTS COVID-19

Telling us that you are dissatisfied with a service provided by the Council, or telling us about a failure in service provision, can help us to stop making the same mistakes again and help us to improve our services.

The following data doesn't show all the complaints received by Parking Servicesduring the last two years — only those where the correspondent was dissatisfied with the responsethey received to an informal complaint or enquiry and wished to escalate the matter through the Council's formal complaint procedure.

The 'Complaints' column denotes that the origin is from individuals. 'Members Enquiries' are complaints or questions received from Councillors or MPs on behalf of constituents; 'Late' means the number of complaints/enquiries responded to past the designated time frame (10 days).

In March 2020 the country went into lockdown to help prevent the spread of covid-19. The pandemic has had an impact on everyone and has created pressures on residents and local business owners – both financially and in terms of physical and mental health. The Parking Services team have responded to the pandemic in line with advice from central government, London Councils, the British Parking Association, the wishes of local Councilors, and the best judgement and moral compass of its leadership team. Whilst there have clearly more important things than parking with which we have all concerned ourselves over the last 6 months, the Council has adjusted its services to meet the new needs that have arisen due to Covid-19.

To date, these measures include:

- A 50% reduction in parking enforcement staff presence during full lockdown, with special focus put on protecting access to parking and loading for key workers
- A reduction in the types of debt collection activities our enforcement agents undertake, temporarily
 halting doorstop visits and recommencing debt collection whilst considering the impact covid-19 may
 have on debtor's ability to make payments
- The refunding/extension of car park/business permits for nearly 3 months and the provision of free parking to some key workers for up nearly 6 months (still ongoing at the time of writing)
- Changes to fees and charges that were due to be implemented in 1st April have been put on hold till 1st October.
- Suspending numerous parking spaces outside shops to allow for footpaths to be widened and help people maintain safe distances from one another
- Special focus on the cleaning and disinfecting of shared surfaces in our car parks
- Some members of staff from the parking team were temporarily redeployed to facilitate the distribution of food parcels to those who needed to shield between March and July

FINANCIAL INFORMATION

The objective of Parking Servicesis to manage parking demands in a safe and appropriate way rather than generate income or revenue. However, any income generated through parking enforcement is ringfenced by law and must be spent on transport and highways related initiatives.

In 2019/20, £21.400m was raised from on and offstreet parking income. The expenditure items directly associated with running a parking service totalled £5.644m. The remaining income is classed as 'surplus' and totals £15.756m. A contribution of £12.167m was made towards the council's cost of concessionary fares in 2019/20, including funding of the Freedom

The surplus contributes towards the part funding of the Freedom Pass, which provides free travel inside London to older and disabled residents.

The surplus generated by the service also funded several projects including the introduction of Controlled Parking Zone extensions, the removal of graffiti from street furniture and the parking enforcement operation into the investigation and prevention of blue badge misuse.




