 - 2. The general effect of the Parking Places Orders would be to extend the shared use parking in Carlton Gardens on the north-east side south of Carlton Road by 4.2 metres in place of the same length of permit holder parking.
- 3. The general effect of the Waiting and Loading Restriction Amendment Order would be to impose waiting restrictions applying "at any time" in the lengths of Carr Road specified in the Schedule to this Notice. 4.

Carr Road

- (a) north-east side, between the south-eastern side of the alleyway lying between No. 340 and 342 Carr Road and a point 1 metre north-west of the north-western side of the alleyway;
- (b) the southwest side
- between a point 1 metre south-east of the south-eastern side of the alleyway lying between No. 305 and 307 Carr
 - Road and the north-western side of the alleyway; (ii) between the south-eastern side of the alleyway lying between No. 247b/247c and 249 Carr Road and a point 1 metre north-west of the north-western side of the alleyway.
