- 4. The car parks would be open (a) during 7.30am to 5.30pm in January, February, November and December (b) 7.30am to 7pm in March and October (c) 7.30am to 8pm in April and September (d) 7.30am to 9pm in May and August and (e) 7.30am to 10pm in June and July.
