#### 1. What is the proposal looking to achieve? Who will be affected?

A small grants fund will support small voluntary and community groups to develop grassroots projects. The fund will be used as a contribution towards the cost activities, projects and services which are consistent with council and EBBP priorities.

The proposal is looking to provide the voluntary and community sector with vital funding to develop neighbourhood based activities/services. Small grants will fund support to a variety of voluntary organisations, many of which focus on one or more of the protected characteristics. Specific criteria for the small grants will be developed following the outcome of the consultation process but the focus will be on

- Targeting support at those most in need to reduce inequality
- Helping people help themselves and each other
- Helping people take advantage of the opportunities in their neighbourhood
- Empowering people to take action to improve their communities

The proposed budget is up to £0.080m with voluntary sector organisations being able to apply for a maximum amount of £5,000. The fund will be managed by the council.

Local residents and communities across the borough in all areas will be directly affected by this proposal as well as voluntary and community sector organisations who will deliver the activities/services.

#### 2. What will the impact of your proposals be?

A small grants fund will provide local, neighbourhood based projects, activities and services which will enable greater involvement by residents and local communities in improving their quality of life. The proposal will positively impact local residents and communities as it will allow for a broader range of activities and services to be delivered at a neighbourhood level and for a wider range of organisations to develop their own projects and activities to help local communities and residents.

The proposed budget could allow for over 16 projects to be developed each year which would directly benefit a large number of local people and communities.

#### Appendix 1: Legal obligations under Section 149 of the Equality Act 2010:

- As a public authority we must have due regard to the need to:
