## **NOTICE OF MAKING OF TEMPORARY TRAFFIC ORDER FOR PLANNED WORKS AFFECTING: VARIOUS ROADS, HANWELL**

Ealing Council intends to make the following temporary traffic order under section 14(1)(a) of the Road Traffic Regulation Act 1984:

### **Title of order**

This order can be referred to as: **Temporary traffic order for planned works - TT 3593 Various Roads, Hanwell - 2022.**

### **Reason for order**

This order is needed to allow for works taking place on or near the road. These works involve Cadent Gas replacing gas mains in various roads, Hanwell.

### **Effect of order**

1. To allow for gas mains replacement, various roads will be closed under works phases 1,2,3,4,5,6,7 & 8, as illustrated in the schedule attached to this order.
2. The following temporary restrictions on vehicle movements will take effect from 25th July 2022:
  - (a) No entry into the fully closed section of roads listed in the schedule attached to this order;
  - (b) No waiting, loading or unloading on either side of the carriageway within the fully closed section.
3. The above temporary restrictions and prohibitions will only apply at specified locations where appropriate traffic signs are provided and displayed in accordance with Chapter 8 of the Traffic Signs Manual.
4. While the temporary restrictions are in place, displaced vehicles should follow the diversions displayed in place to reach their destinations and comply with any traffic management measures.
5. This Order does not apply to:
  - (a) anything done at the direction of a police officer in uniform or a police community support officer (PCSO);
  - (b) any vehicle being used for police, fire brigade or ambulance purposes.

### **Date order will come into force**

25th July 2022

### **Maximum duration of order**

This order will expire on 24th January 2024, or upon completion of works which is expected to be 12th September 2022 - whichever is sooner.

All dates are subject to weather and are indicative

- Phase 1 - Junction closure of Christopher Avenue - 25/07/22 to 31/07/22
- Phase 2 - Junction closure of Chepstow Road and Clitherow Avenue - 01/08/22 to 07/08/22
- Phase 3 - Junction closure of Elthorne Avenue - 12/08/22 to 19/08/22
- Phase 4 - Junction closure of Cumberland Road - 20/08/22 to 24/08/22
- Phase 5 - Junction closure of Oaklands Road - 25/08/22 to 28/08/22
- Phase 6 - Junction closure of one side of Townholm Crescent - 29/08/22 to 01/09/22
- Phase 7 - Junction closure of other side of Townholm Crescent - 02/09/22 to 05/09/22
- Phase 8 - Junction Closure of Haslemere Avenue - 06/09/22 to 12/09/22
