AMENDMENTS IN FEDERAL ROAD

THE EALING (PERIVALE SCHOOL STREETS) (NO. 1) TRAFFIC ORDER 2022

THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. 865) ORDER 2022

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing on the 6th September 2022 made the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the School Streets Order will be to revoke and re-enact the Ealing (Perivale School Streets) (No. 1) Traffic Order 2021 and the Ealing (Prescribed Route) (No. 174) Traffic Order 2021 so as to
 - (a) reinstate the 7-foot width restriction in Federal Road so that motor vehicles proceeding northbound which have been issued with SS1 permits can proceed through the restriction at all times;
 - (b) allow all motor vehicles to proceed southbound through the above width restriction except during school street hours when it will be restricted to SS1 permit holders;
 - (c) allow residents in Bethlehem Close and Federal Road - Nos. 51 to 73 (odd) and Nos. 50 to 72 (even) to apply for SS1 permits.
3. The general effect of the Waiting and Loading Restriction Order will be to
 - (a) Impose or vary existing waiting restrictions that will apply at any time in the lengths of roads specified in Schedule 1 to this notice;
 - (b) impose restrictions on waiting by vehicles for the purposes of loading or unloading that will apply at any time in the lengths of roads specified in Schedule 2 to this notice
4. The Orders, which will come into operation on 8th September 2022, other documents including plans giving more detailed particulars of the Orders, are available by either e-mailing trafficnotices@ealing.gov.uk or for inspection at Customer Services Reception, Perceval House, 14-16 Uxbridge Road W5 2HL between 9:00am and 4:45pm on Monday to Friday, until the 18th October 2022
5. Any person desiring to question the validity of either of the Orders or of any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984 or that any relevant requirements thereof or any relevant regulations made thereunder has not been complied with in relation to the Orders may make application for the purpose to the High Court by the 18th October 2022.

SCHEDULE 1 (No waiting at any time)

Federal Road, Perivale

- (a) the west side,
 - (i) between a point 2 metres north of the southern boundary of No. 48 Federal Road and the common boundary of Nos. 50 and 52 Federal Road;
 - (ii) between a point 14.00 metres north of the northern kerb-line of Wadsworth Road and a point 6.00 metres north of the southern boundary of No.72 Federal Road;
- (b) the east side, between a point 8.00 metres north of the southern kerb-line of Wadsworth Road and a point 2.7 metres south of the common boundary of Nos. 71 and 73 Federal Road.

Wadsworth Road, Perivale

- (a) the north side, between the western kerb-line of Federal Road and a point 2 metres west of a point opposite the eastern wall of No. 26 Wadsworth Road;
- (b) between the western kerb-line of Federal Road and a point opposite the eastern wall of No. 26 Wadsworth Road.

SCHEDULE 2

(No loading or unloading at any time)

Federal Road, Perivale

- (a) the west side,
 - (i) between a point 2 metres north of the southern boundary of No. 48 Federal Road and a point 13.3 metres south of the common boundary of Nos. 50 and 52 Federal Road;
 - (ii) between its junction with Wadsworth Road and a point 6.00 metres north of the southern boundary of No.72 Federal Road;
- (b) the east side
 - (i) between the southern kerb-line of Perimeade Road and a point 2.4 metres south of a point opposite the southern wall of No. 51b Federal Road;
 - (ii) between its junction with Wadsworth Road and a point 2.7 metres south of the common boundary of Nos. 71 and 73 Federal Road.

Perimeade Road

the south side, between the common boundary of Nos. 69 and 71 Perimeade Road and the eastern kerb-line of Federal Road.

Wadsworth Road, Perivale

- (a) the north side, between the western kerb-line of Federal Road and a point 2 metres west of a point opposite the eastern wall of No. 26 Wadsworth Road;
- (b) the south side, between the western kerb-line of Federal Road and a point opposite the eastern wall of No. 26 Wadsworth Road.
