The Ealing (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 867) Order 2022

- 1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, on the 25th October 2022 made the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation
- Act 1984 as amended by the Local Government Act 1985. The general effect of the Waiting Amendment Order will be (a) to impose waiting restrictions that would 2 apply at any time in the lengths of road specified in Schedule A to this Notice and waiting restrictions for the purposes of loading or unloading that will apply at any time in the lengths of road specified in Schedule B to this Notice and (b) to remove the no stopping restriction in the unnamed road linking Kensington Road with the slip road on the south-east side of Western Avenue and replace it with waiting and loading restrictions

- Any person desiring to question the validity of the Δ Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any relevant requirements thereof or any relevant regulations made thereunder has not been complied with in relation to the Order may make application for the purpose to the High Court by the 6th December 2022. ## A (No waiting at any time)

Cranleigh Gardens both sides, between a point 5 metres east of a point opposite the western boundary of No. 58 Evelyn Grove and a point 5 metres west of a point opposite the eastern boundary of No. 81 Evelyn Grove Evelyn Grove, Southáll

both sides, between a point 6 metres north of the northern kerb-line of Cranleigh Gardens and a point 6 metres south of the southern kerb-line of Cranleigh Gardens

Featherstone Road

the south-west to north-east arm

- (a) the north-west side, between the common boundary of Nos. 2 and 3 Home Villas, Featherstone Road and a point 15.6 metres north-east of that common boundary; (b) the south-east side, between the rear common
- boundary of Nos. 64 and 66 Western Road and the common boundary of Nos. 127 and 129 Featherstone Road.

Meadvale Road, Ealing

the north-east side, between a point 2.00 metres north-west of a point opposite the common boundary of Nos. 33 and 35 Wordsworth Avenue and a point 11.00 metres south-east of that common boundary The unnamed road linking Kensington Road with the slip road on the south-east side of A40 Western Avenue, both sides.

## B (No waiting for the purposes of loading or unloading at any time)

Shakespeare Road W7

the east to west arm, both sides, between the north-eastern kerb-line of Greenford Avenue and a point 15.3 metres northeast of that kerb-line. The unnamed road linking Kensington Road with the slip road on the south-east side of Western Avenue, the south side.
