PROPOSED PARKING/WAITING AMENDMENTS IN MOUNTFIELD ROAD

The Ealing (Ealing Broadway) (Residents Parking Places) (No. *) (Amendment No. *) Order 2022

The Ealing (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. **) Order 2022

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, propose to make the abovementioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.
2. The general effect of the Parking Places Order would be to shorten or lengthen certain permit holder parking places in Mountfield Road.
3. The general effect of the Waiting and Loading Restriction Amendment Order would be to introduce waiting restrictions that would apply "at any time" in the lengths of Mountfield Road specified in the Schedule to this Notice.

All objections must specify the grounds on which they are made and should include the address of the author.

Mountfield Road
the north-west side

- (i) between a point 21.0 metres north-east of the northern kerb-line of Haven Green and a point 27 metres northeast of that kerb-line;
- (ii) between a point 37.0 metres north-east of the northern kerb-line of Haven Green and a point 42 metres northeast of that kerb-line;
- (iii) between a point 59.5 metres north-east of the northern kerb-line of Haven Green and a point 66.5 metres north-east of that kerb-line;
- (iv) between a point 86.5 metres north-east of the northern kerb-line of Haven Green and a point 93 metres northeast of that kerb-line;
- (v) between a point 14 metres north-east of a point opposite the common boundary of Nos. 18 and 19 Mountfield Road and a point 23.5 metres north-east of that common boundary;
- (vi) between a point 30.0 metres north-east of a point opposite the common boundary of Nos. 18 and 19 Mountfield Road and a point 38.5 metres north-east of that common boundary
