



Methodology

Following project inception, the Infrastructure Topic Paper followed five stages:

Stage 1 - Context and Policy Review

This stage provided an overview of national and regional policy and how the Topic Paper aligns with the development of the Regulation 18 Local Plan. It also included the gathering of all relevant existing studies undertaken by Ealing Council, its partners and other infrastructure providers to compile a concise summary of the wider evidence base.

Stage 2 – Infrastructure Issues and Opportunities

This stage identified the existing issues and opportunities of scoped infrastructure types, providing: a summary of evidence base documents; an overview of each infrastructure type and funding streams (where known); a summary of the key issues and opportunities; and a review of planned investment to address any deficiencies.

Stage 3 – Ealing Council Engagement

This stage entailed engagement with internal stakeholders at Ealing Council to test preliminary findings from Stage 2 and gather information on each infrastructure type beyond that in published documents. Emerging infrastructure projects and planned investment were also discussed and documented.

Stage 4 – Next Steps

This stage identified where there are any gaps in the existing information regarding infrastructure types and mapped out the next steps and further analysis and engagement necessary to develop the full Infrastructure Delivery Plan.

Stage 5 – Finalised Topic Paper

This stage finalised the Topic Paper write-up, summarising the information gathered through stages 1 to 4 to provide an overview of current infrastructure provision across the borough.






Policy context

Policy context - national

The framework for infrastructure planning





The revised National Planning Policy Framework (NPPF) (2021) states that local planning authorities must prepare a robust and evidence-based Local Plan which seeks to deliver sustainable development. As part of the statutory requirement to produce a Local Plan, national policy has placed a greater responsibility on local planning authorities to plan for the delivery of various forms of infrastructure. Specifically, the NPPF states that both strategic (paragraph 20) and non-strategic (paragraph 28) policies should set out the overall strategy for the pattern, scale and quality of development, and make sufficient provision for infrastructure, including transport and community facilities (such as health and education).

More guidance on infrastructure planning is provided by the Planning Practice Guidance (PPG), with the following sections being of particular relevance: viability (2019), planning obligations (2019) and planmaking (2021). The Local Plan should identify what infrastructure is required and how it can be funded and brought forward. This requires working alongside infrastructure providers to identify deficits, requirements and opportunities for provision.

Planning obligations assist in mitigating the impact of unacceptable development to make it acceptable in planning terms. Planning obligations may only constitute a reason for granting planning permission if they meet all the tests set out in Paragraph 57 of the NPPF: necessary to make the development acceptable in planning terms; directly related to the development; and fairly and reasonably related in scale and kind to the development. The PPG states that local authorities should consider the combined total impact of such requests, so they do not undermine the deliverability of the plan.

Following the 2019 amendment to the Community Infrastructure Levy (CIL) Regulations (2010), it is a legal requirement for all local authorities to prepare Infrastructure Funding Statements (IFS). IFSs should be

used to set out the anticipated funding from developer contributions and the choices local authorities have made about how these contributions will be used to fund infrastructure. At examination this can be used to demonstrate the delivery of infrastructure throughout the plan-period.


The Levelling Up and Regeneration Bill sets out a direction of travel for planning and supports the levelling up agenda. The Bill proposes to replace CIL with a framework for a new mandatory levy system. The new levy will be set locally, with financial contributions based on the gross development value of the property when permission is granted, rather than on floorspace. The thresholds of the levy are proposed to be based on the context of a given site. These changes could lead to improved flexibility and potentially increased revenue to support infrastructure delivery, but, until further detail is brought forward through legislation. there is still a great deal of risk and uncertainty as to how it will function. The development of a CIL for Ealing will need to take account of this changing context. As part of the local plan, the council intends to develop a CIL to secure funds to support necessary infrastructure across Ealing.

Policy context – regional and sub-regional



The framework for infrastructure planning









At the regional level, *The London Plan* (2021) provides the Spatial Development Strategy for Greater London and sets out a framework for how London will develop over the next 20-25 years. The Plan is part of the statutory development plan for London. As such, its policies will inform decisions on planning applications in the London Borough of Ealing and Ealing's New Local Plan must be in 'general conformity' with the London Plan.

The London Plan is underpinned by the Mayor's vision for 'Good Growth'. This is defined as growth which is socially and economically inclusive and environmentally sustainable. The plan emphasises that inclusive growth should provide access to good quality community spaces, services, amenities and infrastructure which are all critical in accommodating strong communities.

The London Plan places great importance on the provision of local infrastructure to support the scale of growth identified through Local Plans. It recognises that infrastructure capacity and needs should be identified and assessed through Infrastructure Delivery Plans (IDPs) and Local Plans. Boroughs should then work with applicants and infrastructure providers to ensure that there is sufficient capacity to support proposed densities (including the impact of cumulative development).

The West London Strategic Infrastructure Delivery Plan (2022) provides information on the future strategic infrastructure requirements for the seven London Boroughs that form the West London Alliance (WLA). The document notes a lack of orbital connectivity within the region, poorly connected strategic growth areas, the

need for growth to drive energy decarbonisation, flood risk, water stress, open space deficiencies and the role of digital connectivity in driving growth sectors.

The West London Build and Recover Strategy (2020) sets out a bold plan to drive post-Covid economic recovery by working on shared priorities, including 'Housing and Infrastructure'. Through this plan, Ealing Council affirmed its intention to: work with landowners, developers and the construction industry to tackle barriers to development (including infrastructure provision), adopt a Local Plan that gives certainty to support the provision of housing and infrastructure, work with Transport for London to develop the West London Orbital business case and with the WLA to find new ways of funding and delivering strategic infrastructure needed to support growth, and to utilise compulsory purchase order powers where appropriate.

The West London Sub-Regional Transport Plan (2016) emphasises the importance of enhancing north-south public transport connectivity, identifies measures to increase cycling and proposes improvements for walking routes and improvements to safety and security.

Policy context – local

The framework for infrastructure planning





Ealing Council is currently developing the borough's new Local Plan. The new Local Plan will provide the spatial strategy for the borough, allocate key sites for development, outline how the borough will develop in line with the London Plan and provide additional development management policies where necessary.

Reflecting local priorities, Ealing Council has identified three inter-related 'Core Themes' that will be embedded across the emerging Local Plan. The three core themes are fully informed by the social, economic and environmental challenges and trends the borough is expected to encounter over the next fifteen years. The themes are Tackling the Climate Crisis, Fighting Inequality and Creating Good Jobs and Growth.

Ealing Council is also developing a spatial vision and strategic objectives for the borough, responding to the council's core themes, identified issues and opportunities and the Local Plan policy framework. Together, these elements comprise a local framework within which infrastructure will be planned for and delivered.

The core themes and spatial vision presented here will be consulted on as part of the Local Plan's Regulation 18 stage.

Known funding streams

The impact of Covid-19 has resulted in an uncertain future for Sports and Leisure funding, with few opportunities existing for substantial funding streams. The following known funding streams have been identified through consultation with Ealing Council:

- Sport England
- The London Marathon Charitable Trust the Trust is hoping to re-open grant applications in January 2023
- John Lyon education focused funding which often funds staff as opposed to built infrastructure
- Heathrow Community Trust
- Football Foundation recently launched a new fund at Gunnersbury for informal play areas. The Foundation also provide small grants for football clubs, stadia and small building developments
- Lawn Tennis Association currently has a small grant out for tennis clubs, for which Ealing Council are at Stage 2 for grass roots tennis courts funding.
- Individual sports club fundraising capable of funding smaller projects
- Padel-specific funding Padel court developments have come forward which are fully funded and only require land from the council
- London Sport charities can apply for many funding streams, however there is less available for council. Ealing Council have previously partnered with voluntary organisations to tap into this funding stream

The impact of Covid-19 has resulted in an uncertain future for Community Facilities funding, with few opportunities existing for substantial funding streams. The following known funding streams have been identified through consultation with Ealing Council:

• The National Lottery Community Fund

Green infrastructure and open space

Known funding streams

Green infrastructure and open space has not received capital funding for the past four years, with there instead being a significant reliance on S106 funding. In the future, harnessing funds from the Community Infrastructure Levy will help tackle the challenges associated with development specific S106 contributions, enabling funds to be spent more broadly.

The Mayor of London announced a tree planting funding package in July 2022, which will incorporate the following:

- A £0.8m top up to the Mayor's Grow Back Greener community grant scheme. As well as supporting projects that increase access to green space the fund will now also support communities and boroughs to plants more trees for shade.
- A £1m street trees programme including supporting borough sign up to the Trees for Streets tree sponsorship initiative and match funding 1,000 trees in areas of low canopy cover, helping residents, businesses and boroughs to green our streets. The Mayor will also be funding borough surveys to identify potential tree planting locations, ready to support more tree planting next winter.
- £320k for community tree packs to community groups and schools with The Conservation Volunteers
- £1m for transformational tree planting and woodland creation projects to create shady groves in areas of high heat risk. Call for sites from landowners and developers for ideas and locations.
