Introduction

The Adopted Policies Map illustrates all sitespecific policies in all local plan documents in map form. The council adopted the policies map on 10 December 2013. Some further modifications have been implemented following the adoption of the West London Waste Plan in July 2015, the Planning for Schools DPD in May 2016 and together with neighbourhood plans for Central Ealing (approved October 2017) and West Ealing (approved May 2018).



This 'Atlas of Change' sets out any proposed changes to the Adopted Policies Map in this draft Local Plan (reg 18). These arise from a review of Green Belt and Metropolitan Open Land (MOL) and suggested amendments to Locally Significant Industrial Sites (LSIS) in Southall.

Below is a table setting out the schedule of proposed changes to the Adopted Policies Map together with a series of maps which detail them. Rows 1-87 of the table and Maps 1-87 deal with Green Belt/MOL and Row 88/Map 88 deal with LSIS. Map 88: Employment area changes These changes should also be read in conjunction with the proposed Development Sites set out in each of the 7 town plans in Chapter 4 which if proposed for allocation at Regulation 19 will also feature on the Adopted Policies Map.

There are no other proposals at the moment to alter any other policy designations in the Adopted Policies Map.








Map 71 - MOL11 – Addition of River Brent running through the site







Map 75 - MOL12 – Removal of residential properties at the intersection of Ruislip Road East and Argyle Road









Map 78 - MOL14 – Small addition/boundary adjustment along Horsenden Lane South

Map 80A - MOL15 – Addition of Grand Union Canal running through the site













Map 87A - MOL19 – Removal/boundary adjustment along the southern and western edges of the site
