## CLIFTON ROAD GREENFORD - PROVISION OF CONTRA FLOW FOR CYCLES

## RUISLIP ROAD EAST QUIETWAY WAITING RESTRICTION PROPOSALS

The Ealing (Prescribed Routes) (No.184) Traffic Order 2022 The Ealing (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 871) Order 2022

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, on the 13th December 2022 made the above-mentioned Orders under sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.
2. The general effect of the Prescribed Routes Order will be to provide for contra flow working for pedal cyclists in Clifton Road Greenford.
3. The general effect of the Waiting and Loading Restriction Order will be to (a) impose double yellow line waiting restrictions applying at any time in the lengths of Ruislip Road East specified in Part A of the Schedule to this Notice and (b) impose single yellow line waiting restrictions applying between 7am and 7pm on Mondays to Fridays in the length of Ruislip Road East specified in Part B of the Schedule to this Notice
4. The Orders, which will come into operation on 15th December 2022, other documents giving more detailed particulars of the Orders including plan, are available by e-mail from [trafficnotices@ealing.gov.uk](mailto:trafficnotices@ealing.gov.uk) or by inspection at Customer Services Reception, Perceval House, 14-16 Uxbridge Road W5 2HL between 9:00am and 4:45pm on Monday to Friday, until the 24th January 2023.
5. Any person desiring to question the validity of either of the Orders or of any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984 or that any relevant requirements thereof or any relevant regulations made thereunder has not been complied with in relation to the Order may make application for the purpose to the High Court by the 24th January 2023.

### SCHEDULE

#### A (At Any time waiting restrictions)

Ruislip Road East  
the south and south-east side

- (i) between a point 85 metres south-east of the eastern kerb-line of Costons Lane and a point 118 metres south-east of the eastern kerb-line of Costons Lane;
- (ii) between a point 69.4 metres west of the western kerb-line of the westernmost carriageway of Cuckoo Avenue and a point 102.2 metres west of that kerb-line.

#### B (Waiting restrictions applying 7am to 7pm on Mondays to Fridays)

Ruislip Road East  
the south and south-east side, between a point 118 metres south-east of the eastern kerb-line of Costons Lane and a point 20 metres south-west of the south-western kerb-line of Greenford Avenue
