

# **LONDON BOROUGH OF EALING**

## **PROPOSED WAITING RESTRICTIONS IN QUILL STREET, NORTHOLT GARDENS, BORDARS ROAD AND GREENFORD ROAD**

The Ealing (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. \*\*) Order 2022  
The Ealing (Free Parking Places) (No. 1, 2014) (Amendment No. \*) Order 2023

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, propose to make the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.
2. The general effect of the Waiting and Loading Restriction Amendment Order would be to introduce waiting restrictions that would apply "at any time" in the lengths of roads described in Schedule 1 to this Notice and formalise waiting restrictions including restrictions on loading or unloading that would apply "at any time" in the length of road described in Schedule 2 to this Notice.
3. The general effect of the Free Parking Place Order would be to formalise the removal of a free parking place in the vicinity of No. 18 Southwell Avenue and its replacement with at any time waiting restrictions.

### **SCHEDULE 1 (No waiting at any time)**

#### **Bordars Road**

the north-west side, between a point 7.30 metres north-east of the north-eastern kerb-line of Harp Road and a point 9.30 metres north-east of that north-eastern kerb-line of Harp Road.

#### **Northolt Gardens**

between its junction with Sudbury Heights Avenue and a point 3 metres north-east of the north-eastern wall of No. 205 Sudbury Heights Avenue

#### **Quill Street**

(a) the north-west side, between a point 35.6 metres north-east of the north-eastern side of the accessway to Halfords and its southern extremity, including the accessway to Halfords;

(b) the south-east side, between a point 10.00 metres north-east of the north-eastern side of the accessway nearest Hanger Lane and its southern extremity.

#### **Sudbury Heights Avenue**

the south-west side, between the common boundary of Nos. 201 and 203 Sudbury Heights Avenue and a point 3 metres east of the common boundary of Nos. 205 and 207 Sudbury Heights Avenue.

### **SCHEDULE 2**

**(No waiting and no loading/unloading at any time)**

#### **Greenford Road, Southall**

the west side, between a point 5 metres south of the southern side of the entrance to the AEC fishing club and a point 7 metres north of the northern side of that entrance.
