## THE EALING (ELECTRIC SCOOTER TRIAL AND PEDAL CYCLE HIRE PARKING PLACES) (NO.1) TRAFFIC ORDER 2023

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Ealing, propose to make the above-mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Order will be to revise certain parking places situated on the footway for electric scooters provided for hire in the trial of electric scooters so as to include pedal cycles for hire. They will be located in the roads specified in the Schedule to this Notice.
