1. **NOTICE IS HEREBY GIVEN** that the London Borough of Ealing on the 18th April 2023 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Telephone Parking Places Order will be to remove 39.2 metres of the shared use parking place in Trumpers Way by the Scout Hut and replace it with at any time waiting restrictions.
3. The general effect of the Waiting Amendment Order will be to extend waiting restrictions applying at any time in Trumpers Way to the lengths of Trumpers Way in the Schedule to this Notice.
4. The Orders, which will come into operation on 20th April 2023, other documents including plans giving more detailed particulars of the Orders, are available by either e-mailing trafficnotices@ealing.gov.uk or for inspection at Customer Services Reception, Perceval House, 14-16 Uxbridge Road W5 2HL between 9:00am and 4:45pm on Monday to Friday, until the 30th May 2023.
5. Any person desiring to question the validity of either of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any relevant requirements thereof or any relevant regulations made thereunder has not been complied with in relation to the Order may make application for the purpose to the High Court by the 30th May 2023.

(Waiting at any time)

Trumpers Way

- (a) The north-west side, between a point 10 metres south-west of a point opposite the south-western abutment of the Canal Bridge, Trumpers Way and a point 55 metres south-west of a point opposite the south-western abutment of the Canal Bridge, Trumpers Way;
- (b) The South-east side,
 - (i) between a point 10 metres south-west of a point opposite the south-western boundary of the Scout Hut Trumpers Way and a point 29.20 metres north-east of a point opposite the south-western boundary of the Scout Hut Trumpers Way;
 - (ii) between a point 10 metres south-west of a point opposite the south-western abutment of the Canal Bridge, Trumpers Way and a point 63.70 metres south-west of a point opposite the south-western abutment of the Canal Bridge, Trumpers Way.
