NOTICE OF VARIATION

REVISED CHARGES FOR PERMITS AND VOUCHERS

- NOTICE IS HEREBY GIVEN that the Council of the London Borough of Ealing, under section 46A of the Road Traffic Regulation Act 1984 intend to revise charges for the cost of some on-street parking permits and vouchers.
- The general effect of the changes will be to increase the cost of annual resident parking permits which allow for the parking of a vehicle in a permit parking place in any street in a part day zone.

Each additional vehicle at the same address will incur an additional charge of £60 multiplied by the number of additional vehicles at that address.

Older diesel vehicles (manufactured in 2015 or before) would be subject to an additional charge of £55.

- The charges for business, doctors and veterinary permits will be increased from £806 per annum to £850 per annum.
- The charges for static car club permits will be increased from £800 per annum to £806 per annum
- The charge for the annual all zone permits will be increased from £1007 per annum to £1100 per annum
- The charge for annual carers permits will be reduced from £48 per annum to £10 per annum.
 The charge for the annual disabled bay permit will be increased from £32 per annum to £35

 8. The charge for essential users permits will be increased from £365 per annum to £400 per

- The charge for religious permits will be increased from £180 per annum to £200 per annum.
 The discount for permits bought in bulk (20 for price of 15) will be unchanged.
 Visitors vouchers hourly rate will remain unchanged at 80p per hour. The maximum £4.50 daily
- cap will be increased to £4.95.
- 11. Business visitor vouchers and service vouchers will be increased from £2.40 to £2.60 per hour.
- 12. The administrative charge relating to permits will be increased from £16 to £17.60
- 13 The revised on-street parking permit and voucher charges specified in this notice will take effect on or after the 2nd May 2023.
