PROPOSED PARKING/WAITING AMENDMENT IN SHRUBLANDS LANE AND WOODLANDS AVENUE

The Ealing (Waiting and Loading Restriction)

(Special Parking Area) (Amendment No. **) Order 2022

The Ealing (Parking Places) (Stop and Shop with additional Cashless Parking) (No.1, 2022)

(Amendment No. *) Order 2022

The Ealing (Free Loading Places) (Amendment No. *) Order 2023

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.
2. The general effect of the Waiting and Loading Restriction Amendment Order would be to introduce waiting restrictions that would apply "at any time" in the lengths of Shrubland Lane and Woodlands Avenue described in the Schedule to this Notice.
3. The general effect of the Loading Places Order would be to provide a loading bay in Woodlands Avenue which would operate between 7am and 7pm on Mondays to Saturdays.
4. The general effect of the stop and shop parking places Order would be to provide a 1-hour free parking place in Woodlands Avenue. The operational hours of the parking place would be between 9 am to 5.30 pm Mondays to Fridays and no return to the bays would be permitted for 1 hour.
5. Vehicles would be permitted to remain in this parking place beyond the 1-hour free parking period for an additional period of up to 2 hours on payment of an emissions-based parking charge of between 70 pence and £1.40 per hour. The parking charge would be payable through the telephone payment system operated by Paybyphone and would be required to be paid for by the end of the free parking period.

SCHEDULE (No Waiting at any time)

Shrublands Lane

The whole of the southern arm.

Woodlands Avenue

- (a) the east side;
- (b) the west side

- i. between the southern kerb-line of High Street, Acton and a point opposite the southern kerb-line of Shrublands Lane;
- ii. between a point 22 metres south of a point opposite the southern kerb-line of Shrublands Lane and the southern extremity of Woodlands Avenue, including the southern side.
