 to provide a new zebra crossing in Merrick Road to
 the west of the mini roundabout at the junction with
 Healum Avenue. This crossing would have a parallel
 crossing for cyclists installed next to the zebra stripes.
 The controlled area for vehicles would extend
 16 metres on the west side of the crossing and
 4.5 metres on the east side.
