1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing ("the Council") proposes to make the above-mentioned Orders under sections 6, 45, 46, 49, 63 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
2. The general effect of the Bikehanger Order would be to provide for the installation of bikehangers in.
CLARE ROAD, Greenford, the south-west side, near the south-eastern wall of Clare Court. COURTFIELD GARDENS, W13, the north-west side, east of the common boundary of Nos. 19 and 21 Courtfield Gardens. CROSSMEAD AVENUE, Greenford, the south side, 4.5 metres east of a point opposite the western boundary of No. 63 Eastmead Avenue. DEANS ROAD, W7 the south-west side, 8.00 metres north-west of the north-western kerb-line of Cambridge Road. GROVE AVENUE W7, the main south to north arm, the east side, 10.00 metres north of the northern kerb-line of Cuckoo Lane. GURNELL GROVE, the east side, 4.00 metres north of a point opposite the northern boundary of Peregrine Court HAMMOND ROAD, Southall, the westernmost east to west arm, the north side, 14.00 metres east of the eastern kerb-line of King Street, HAVELOCK ROAD, the south side, in a lay by from a point 7.5 metres west of the western kerb-line of Lockwood Road HUMES AVENUE, the south-east side, north-east of the common boundary of Nos.44 and 46 Humes Avenue. ROSEMOUNT ROAD, W13, the north-west side, 5.00 metres north-east of the north-eastern kerb-line of Charles Road. Bikehangers are secure shelters for bicycles that are 2.6 metres long and 2 metres wide.
3. The general effect of the 'Parking Places Amendment' Orders would be to reduce in length certain parking places in the roads listed in paragraph 2 above of this notice to accommodate the introduction of the bikehangers.
