- I. Transport for London hereby gives notice that it intends to make the above named Traffic Order under section 14(1) of the Road Traffic Regulation Act 1984 for the purpose specified in paragraph 2. The effect of the Order is summarised in paragraph 3.
- The purpose of the Order is to enable highway improvement and resurfacing works to take place on the A4 Cedars Road/ Ellesmere Road.
- 3. The effect of the Order will be to prohibit any
  - (1) entering or exiting Sutton Court Road northern arm at its junction with the A4 Ellesmere Road/ Cedars Road;
  - (2) entering or exiting Sutton Court Road southern arm at its junction with the A4 Ellesmere Road/ Cedars Road;
  - (3) entering or exiting Eastbourne Road at its junction with Ellesmere Road;

Works will be phased such that some restrictions will apply only at certain times.

The Order will be effective at certain times between 14th February 2022 and 24th May 2022, every night 9:00 PM until 5:00 AM or when the works have been completed whichever is the sooner. The prohibitions will apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

- (1) any vehicle being used for the purposes of those works or for fire brigade, ambulance or police purposes;
