

LONDON BOROUGH OF EALING LICENSING ACT 2003: PUBLIC NOTICE FOR A NEW/VARIATION TO PREMISES LICENCE

Representations must relate to one or more of the four licensing objectives (prevention of crime and disorder, public safety, prevention of public nuisance, and protection of children from harm) and must include your full name and residential address. Anonymous representations will not be accepted.

GUIDANCE NOTES FOR APPLICANTS

The notice must be printed legibly or typed in black ink in a font equal to or larger than 16 and printed on A4 pale blue paper.

Insertions

- (1) Name of applicant
- (2) Delete new or variation as applicable
- (3) Name of premises
- (4) Address of premises
- (5) Summary of proposed licensable activities, dates and timings or variations
- (6) Last date for representations (28 consecutive days from the day after the application was submitted)
- (7) Name of applicant
- (8) Dated the day after the application was submitted.

Consultation Period

The last date for representations is 28 consecutive days after the day on which the application was submitted to the Council. The notice shall be displayed throughout this period and failure to do so may result in the consultation period being restarted.

Display of notice

The completed notice shall be displayed prominently at or on the premises to which the application relates where it can be conveniently read from the exterior. In the case of premises 50 metres square a further notice in the same form shall be displayed every 50 metres along the perimeter of the premises abutting the highway.

Newspaper Advert

The notice must also be published in a local newspaper circulating in the vicinity of the premises. You will need to ensure that the notice is published at least once within 10 working days after the day on which the application was submitted to the Council.
